Why join the Stults Farm C.S.A. farm share?

Stults Farm C.S.A. (Farm Share) membership gives you the satisfaction of knowing that each week, you will be eating farm fresh produce only grown by Stults Farm.

A farm share membership allows a member to better understand the challenges of farming and offers you the opportunity to develop a greater appreciation for your farmer.

A Stults Farm C.S.A membership have the option of choosing either Monday, Tuesday or Wednesday as their weekly pickup day.

When produce becomes very abundant, members will be allowed to take extra produce provided on the free table, when they come to pick up their weekly farm share.

Produce provided in your farm share is determined on the success and maturity of the crop being grown. Remember: Stults Farm does not buy produce for your farm share. Every fruit & vegetables in your basket is grown by Stults Farm!

Produce that can be in your basket, depending on the season: Strawberry, Peas, Sweet Corn, Tomatoes, Zucchini, Potatoes, Eggplant, Peppers, Cucumbers, Blackberry, Peaches, Apples, Broccoli, Cabbage, Watermelon, Winter Squash.

The cost for a “full share” is \$650.00 which will include a weekly supply of produce valued at \$25.00 per week.

The cost of a ‘half share’ is \$410.00 which will include a weekly supply of produce valued at \$15.00 per week.

The items will be properly placed in your basket. You will be assigned a basket number.

Half share members must remove produce from their basket and place items into their reusable bags to carry home.

Full share members have the option of removing produce from their basket and placing items into their reusable bag to carry home or just take their filled basket home. It is the members’ responsibility to return their empty basket the next pick-up day!

Pick-up time on your assigned day is anytime between 2pm – 6:30pm.

Pick-up location is at Stults Farm, 146 Cranbury Neck Rd. Plainsboro Twp. N.J.

To help you to determine which share best suits your family, here is an example of a weekly share in the beginning of the season:

Full share example:

*8 ears corn
1 Bag Lettuce
3 Bell Peppers
1 Box blackberries
4 cucumbers

1/2 share example:

*4 ears of corn
1 Bell pepper
1 Box blackberries
2 zucchini
1 cucumber

***Please note that sweet corn is a staple food at Stults farm. During the season, sweet corn will be included each week. The amount for the full shares will be 8 ears of corn per week and the amount of corn for a half share will be 4 ears of corn per week. ***

Here is an example of the shares during the height of the growing season:

Full share example:

8 ears corn
3 lb. tomatoes
2 zucchini
4 lb. of potatoes

1/2 share example:

4 ears corn
2 lb. tomatoes
4 lb. potatoes

As the bounty of summer flourishes and higher dollar value produce becomes available, it may seem that the weekly quantity in your basket is lesser compared to the beginning of the season, so remember that your designated dollar value for the weekly produce still remains the same.

Agreement

I have read and understand the above conditions and agree to pick up my produce on the day I chose. I understand that shares cannot be personalized. It is my responsibility to remember to pick up my farm share. If I forget to pick-up my produce on my designated day, then my share will be available to me the following day.

If I am running late, I will text Jill Stults @ 609-865-2442 or Brian Stults @ 609-743-0557 before 6:30 pm so arrangements can be made to pick up my share later that evening.

I understand that my share will consist of an assortment of produce depending on availability and maturing. By signing this agreement, I fully understand the seasonality of New Jersey agriculture and remain open-minded to our changing availability. As a member, I share the risk along with all the other Stults farm share members, in knowing that Mother Nature is in control and that Stults Farm will do its very best in providing me with the appropriate amount of produce that is available weekly. I understand that my payment is nonrefundable.

APPLICATION AND PAYMENT DEADLINE: May 1, 2026 (Some shares could possibly be available past May 1st deadline)
